## **About the Safety and Health Award Recognition for Projects (SHARP)**

This Award recognises large-scale projects or worksites that have exemplary safety and health performance, and workplace safety and health management systems. Examples of winning projects include shipyard projects, construction worksites, and large-scale projects.

Under this Award, applicants may submit only one application per project or worksite. Companies with multiple projects or worksites may submit separate SHARP applications for each individual project or worksite that is registered under the company's name.

Companies applying for SHARP may also apply for the Workplace Safety and Health Performance Awards (WSHPA). Please note that applicants need to meet the separate eligibility criteria for WSHPA.


## Criteria

The criteria below represent the minimum conditions required to qualify for the award. Fulfilling them will not automatically result in an award.

The Award Panel will select award recipients based on their ranked WSH performance and achievements, and all decisions are final. In addition, the Award Panel reserves the right to confer only one award on companies with multiple but identical applications, unless outcomes or achievements cited vary.

### Qualifying Period: 1 January 2025 to 31 December 2025

- Project or worksite with:
  - No fatal or [major](#) injury
  - No dangerous occurrence
  - No breach<sup>1</sup> of WSH and labour matters (including composition fines)
- Project or worksite has implemented a WSH [system or programme](#), including risk assessments and risk management.
- Project or worksite must be subscribed to the Ministry of Manpower's [WSH alert service for WSH Incident Reporting](#).

<sup>1</sup> Includes Stop Work Order, Business Under Surveillance Programme, composition fines including health-related offences from MOM Occupational Safety and Health Division, demerit points, and WSH-related investigations, conviction or prosecution (including pending cases) with regard to workplace and labour matters under the Workplace Safety and Health Act and Employment Act. Excludes COVID-19 related matters.

4. Applicant must be an active business with operations, and not a shell, shelf, or holding company.

**Strengthening WSH Ownership**

5. Contractors and sub-contractors working at the project or worksite must have attained [bizSAFE](#) Level 3 certification or higher.

**Enhancing Focus on Workplace Health**

6. Project or worksite must have implemented [Total WSH](#) that integrates work, safety, and health.
7. Project or worksite must have implemented upstream controls or programmes to prevent [occupational diseases](#) (OD).

**Adopting Technology-enabled WSH**

8. Project or worksite must demonstrate efforts to leverage technology to improve WSH practices or address WSH issues.

## Auditing Services Requirements

Applicants that did not implement the relevant [safety and health management systems](#) or programmes are to engage an approved Auditing Organisation (AO) to complete the [ConSASS](#) or [WSHMS](#) checklist. For items marked as “not applicable”, please state the reason(s) in the “Auditor’s Remark(s)” column.

Applicants are not required to engage an approved AO if their ConSASS or WSHMS checklist was done from October 2025 onwards, and had achieved a total element score of at least 70% for Band III.

### Conduct a Self-check

Applicants are advised to ensure that all criteria have been met, by doing a self-check using the ConSASS or WSHMS checklist, before engaging any auditing services.

### Avoid Conflict of Interest

Applicants are required to engage auditing services from an SAC-accredited WSH AO, whose scope of accreditation covers their industry. A list of SAC-accredited WSH AOs is available on the [Ministry of Manpower’s website](#).

The same AO may provide auditing services to a company for a maximum of two (2) consecutive years. A different AO must be appointed in the third year.

Each auditor may conduct audits for up to three award applications per company (same UEN). For example, a company submitting one WSHPA application and eight SHARP applications must engage three (3) auditors, from the same or different AO(s).

## Evaluation

All supporting documents, records, and data submitted will be verified and assessed. The WSH Council will review incident reports lodged with the Ministry of Manpower (MOM) under the applicant's workplace number. Any discrepancies identified may result in immediate disqualification. A site visit to the applicant's workplace may also be conducted.

## Disqualification


An application may be disqualified if any of the following occurs **before** the announcement of results in **September 2026**:

- a) A workplace accident resulting in a/ an:
  - Fatal accident;
  - Major injury accident;
  - Dangerous Occurrence (DO); and/ or
  - Infringement of legislation under MOM's purview
- b) The application contains inaccurate, false or misleading supporting documents, records or data, or if there is adverse reporting in the media pertaining to the applicant's WSH performance.
- c) An applicant withdraws or amends its WSH Incident Report and/ or an ongoing work injury claim during the period of application. An investigation will be conducted before the application can continue to be considered.

## Notes for SAC-Accredited WSH Auditing Organisations

1. The applicant is to pay the auditing organisation (AO) for services rendered by the auditor.
2. The auditor is required to check whether applicants from the construction, marine and chemical/ manufacturing industries should apply for the WSH Performance Awards or the Safety and Health Award Recognition for Projects (SHARP) before providing any auditing services.
3. The applicant is to provide the auditor with their report and supporting documents to [ConSASS](#) or [WSHMS](#), and the write-up for Section B of “Part 3: Evidence-Based Assessment”. The auditor is required to visit the applicant’s workplace in person to verify the submitted report and supporting documents.
4. The auditor must comply with CT17 requirements, including the prescribed on-site man-days based on industry type and workforce size. For SHARP applications involving the same project as a WSHPA application, a minimum of two (2) on-site man-days is required for each SHARP application.
5. Each audit must be conducted by at least two (2) qualified auditors, comprising one (1) lead auditor and one (1) supporting auditor. Each lead auditor is only allowed to conduct audits for up to three (3) award applications for a company with the same UEN.
6. For completed worksite audits, the auditor may substitute physical inspections (PI) with reviews of records to verify past safety measure implementation. Personnel interviews (IP) with workers, supervisors, and management may still be conducted to validate safety practices. Evidence of both PI and IP must be documented in the audit report.
7. The auditor must check whether the applicant has achieved a total element score of at least 70% for Band III in the [ConSASS](#) or [WSHMS](#) checklist. Evidence gathered and any other comments must be recorded in the “Auditor’s Remarks” column. A score must be allocated in the score card and interview sheets. For items marked as “not applicable”, the auditor must verify and document the reasons in the “Auditor’s Remark(s)” column.
8. The auditor is required to provide his/ her details and complete “Part 4: Auditor’s Details and Declaration Form”. Please indicate the applicant’s strengths, areas for improvement and any other observations, before signing the declaration form.
9. In order to ensure that there is no conflict of interest, an AO cannot be engaged for this award application if it also serves as the applicant’s Certification Body (CB) or safety consultant. Auditors must remain independent throughout the audit.
10. Random checks will be conducted on submitted reports and supporting documents. Any inaccuracies or misconduct identified may result in the applicant’s disqualification, and the auditor and AO may be subject to follow-up action by the relevant authorities.


