About the WSH Performance Awards

This Award recognises companies that have achieved excellent WSH performance, with exemplary safety and health management systems and stellar practices, to safeguard their employees and contractors.

There are three types of WSH Performance Awards: Excellence, Gold and Silver Award.

Type of Award	Description
Excellence	To be shortlisted for evaluation, applicant must be a recipient of the Gold Award for three or more years consecutively.
Gold	To be shortlisted for evaluation, applicant must be a recipient of the Silver Award for three or more years consecutively.
Silver	Good safety and health performance and systems.

Criteria

The criteria below represent the minimum conditions required to qualify for the award. Fulfilling them will not automatically equate to the applicant being awarded.

The Award Panel will select the award recipients based on the ranked WSH performance and achievements, and all decisions are final. In addition, the Award Panel reserves the right to confer one award to companies with multiple but identical applications, unless outcomes or achievements cited vary.

Qualifying period: 1 January 2024 to 31 December 2024

Entry Criteria

- Company with:
 - No fatal or [major](#) injury
 - No dangerous occurrence
 - No breach¹ in WSH and labour matters
- No minor injury → No minimum manhours required
 With minor injury →
 - Minimum 1.5 million manhours
 - Lower than industry injury rate

Strengthen WSH Ownership

5. Contractors and sub-contractors working at all sites must have attained [bizSAFE](#) Level 3 certification or higher.
6. Company must have published WSH performance² as an integral part of the business performance report.
7. Company must demonstrate how they factored in their contractors' WSH performance in awarding contracts and giving incentives.
8. Company must have participated and/ or contributed³ to WSH Council's [programmes](#), [events](#) or [campaigns](#).
9. Company leaders (directors and top management) must have applied the principles outlined in the Approved Code of Practice (ACOP) on Chief Executives' and Board of Directors' WSH Duties.

Enhance Focus on Workplace Health

10. Company must have implemented the [Total WSH](#) concept that integrates work, safety and health.
11. Company must have implemented upstream controls or programmes to prevent [occupational diseases](#) (OD).

Adopt Technology-enabled WSH

12. Company must demonstrate efforts on leveraging technology to improve their WSH practices or address WSH issues.

² WSH Performance includes fatal and non-fatal injury rates, WSH performance, policies, and targets.

³ Examples of contributions include company representatives serving on WSH Council's Committees, Taskforces, Working Groups, hosting site visits for WSH learning journeys and collaborating on events.

Auditing Services Requirements

Applicants are required to complete the [ConSASS](#) 2020 or [WSHMS](#) 2020 checklist. For items indicated “not applicable”, please state the reason(s) in the “Auditors’ Remark(s)” column.

Construction companies or worksites do not need to engage an approved Auditing Organisation (AO) if their ConSASS was done from October 2024 onwards and they had achieved a total element score of at least 70% for Band III.

Conduct a Self-check

Applicants are advised to ensure that all criteria have been met, by doing a self-check using the ConSASS 2020 or WSHMS 2020 checklist, before engaging any auditing services.

Avoid Conflict of Interest

Applicants are to engage auditing services through an SAC-accredited WSH AO, whose scope includes their industry. The list of SAC-accredited AOs is available on the [Ministry of Manpower’s website](#).

The same AO can only provide auditing services for a company for up to two consecutive years. A different AO must be appointed for the third year.

Each auditor is only allowed to conduct audits for up to three Award applications for a company with the same UEN. For example, if a company is submitting an application for WSHPA and eight SHARP projects, please engage three auditors from the same/ different AO(s).

Evaluation

All supporting documents, records and data will be verified and assessed. The WSH Council will be checking all incident reports reported under an applicant's UEN with the Ministry of Manpower (MOM). Any discrepancies found may lead to immediate disqualification. A visit to the applicant's workplace may also be requested.

Disqualification

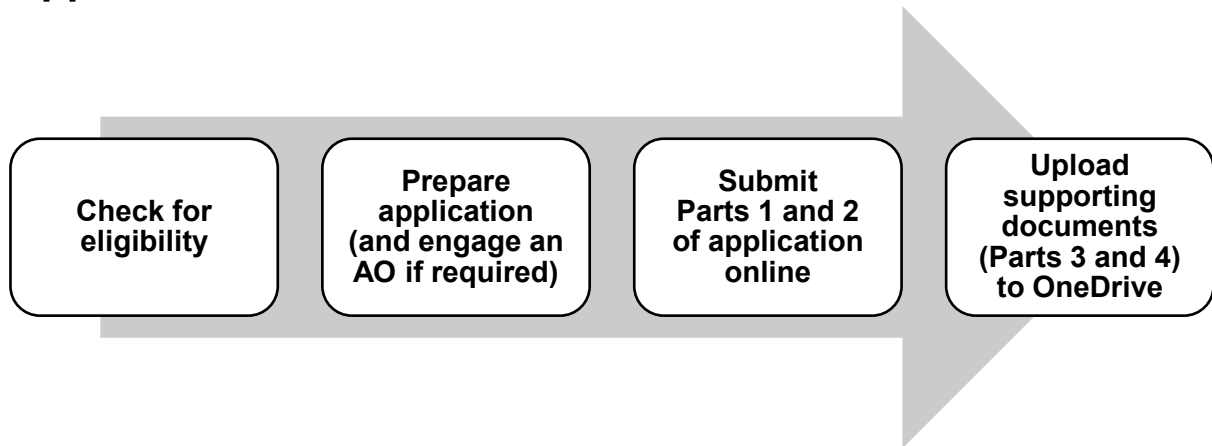
An application may be disqualified if:

- a) A [workplace accident](#) resulting in any of the following occurs **before** the announcement of results in **September 2025**:
 - Fatal accident
 - [Major injury](#) accident
 - Dangerous Occurrence (DO)
 - Infringement of [legislation under MOM's purview](#)
- b) It contains inaccurate, false or misleading supporting documents, records or data, or if there is adverse reporting in the media pertaining to the applicant's or nominating company's workplace safety and health performance.
- c) An applicant withdraws or amends its [WSH Incident Report](#) and/ or an ongoing work injury claim during the period of application. An investigation will be conducted before the application can continue to be considered.

Notes for SAC Accredited WSH Auditing Organisations

1. The applicant is to pay the auditing organisation (AO) for services rendered by the auditor.
2. The auditor is required to check whether applicants from the construction, marine and chemical/ manufacturing industries should apply for the WSH Performance Awards or the Safety and Health Award Recognition for Projects (SHARP) before providing any auditing services.
3. The applicant is to provide the auditor with their report and supporting documents to [ConSASS](#) 2020 or [WSHMS](#) 2020, and the write-up for Section B of “Part 3: Evidence-Based Assessment”. The auditor is required to visit and verify the submitted report and supporting documents at the applicant’s workplace in person.
4. The auditor is required to check whether the applicant has achieved the total element score of at least 70% for Band III in the [ConSASS](#) 2020 or [WSHMS](#) 2020 checklist. The auditor is required to input the evidence gathered and any other comments under the “Auditor’s Remarks” column. A score must be allocated in the score card and interview sheets. For items stated “not applicable”, the auditor must verify the reasons in the “Auditor’s Remark(s)” column.
5. The auditor is required to provide his/ her details and complete “Part 4: Auditor’s Details and Declaration Form”. Please indicate the applicant’s strengths, areas for improvement and any other observations, before signing the declaration form.
6. Random checks on submitted reports and supporting documents will be conducted. Any misdemeanour or misinformation uncovered may lead to the disqualification of the applicant, and the auditor and AO may be taken to task by the relevant authorities.

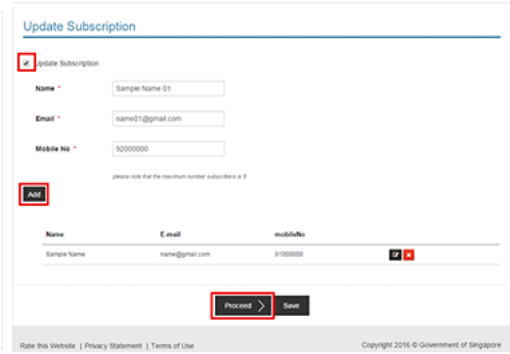
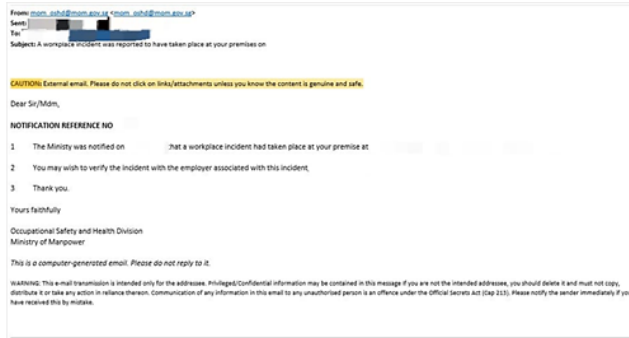
