bizSAFE Partner Award

Recognise bizSAFE Partners who have:

- been proactive and committed in bringing their business partners* on board the bizSAFE programme
- incorporated bizSAFE as part of their procurement requirements





bizSAFE Partner Award – Application Criteria

You are welcome to apply if you have:

- Achieved at least <u>bizSAFE Level 3</u> and is a <u>bizSAFE Partner</u> (excluding WSH Service Providers)
- Included bizSAFE Level 3 and above as a procurement criterion
- Motivated existing business partners* to progress to higher bizSAFE Levels

*Refers to contractors, sub-contractors, tenants, customers, suppliers, vendors, etc.



bizSAFE Partner Award – Application Criteria

- No blacklist record, pending investigation, conviction or prosecution in court by the Ministry of Manpower (MOM)
- Do not have any of the following during the qualifying period:
 - Fatality case
 - Major injury case
 - Dangerous occurrence case
 - Stop work order
 - Business Under Surveillance (BUS)
- Companies applying for the awards <u>may be</u> disqualified if they have cupational diseases within the qualifying period



 - Bonus Initiatives









bizSAFE Enterprise Exemplary Award

Recognise small and medium-sized enterprises (SMEs) that have:

- achieved bizSAFE Star, and
- exhibited outstanding WSH performance and standards.

Companies that have won this award for three (3) consecutive years will be honored with Gold Award.





bizSAFE Enterprise Exemplary Award – Application criteria

You are welcome to apply if you:

- Are a Small and Medium Enterprise (SME)* (excluding WSH Service Providers)
- Have attained bizSAFE Star
- Have implemented a Risk Management Plan that is holistic and pragmatic, where upstream risk controls and personal health risks are considered
 - a) At least 30% shareholding that is local AND
 - One of the following:
 - i. A group employment size of not more than 200 employees (including part-timers) OR;
 - ii. A group annual sales turnover of not more than \$100 million.



bizSAFE Enterprise Exemplary Award – Application criteria

- No blacklist record, pending investigation, conviction or prosecution in court by the Ministry of Manpower (MOM)
- Do not have any of the following during the qualifying period:
 - Fatality case
 - Major injury case
 - Dangerous occurrence case
 - Stop work order
 - Business Under Surveillance (BUS)
- Companies applying for the awards <u>may be</u> disqualified if they have <u>various</u> occupational diseases within the qualifying period

bizSAFE Enterprise Exemplary Award – Application process

- Do a self-score using the RM Implementation Checklist (download from bizSAFE Awards webpage). We recommend a score exceeding 80% before you engage an Assessor to assess your application.
- 2. Submit the application form online via www.wshc.sg/bizsafeawards
- 3. Engage an auditor* to conduct a 3rd party assessment of your application Please refer to the application form for the list of approved auditing organisations.

*Note: Applicants should not engage the same auditing organisation for more than 2 consecutive years.




bizSAFE Enterprise Exemplary Award – Application process

4. After you submit the online form, you will receive a link to the booking system. Notify WSH Council the date, time and location of the assessment via the booking system link* provided in the application form. WSH Council will verify the process by observing the assessment conducted by the assessor.

Mandatory fields for booking system:

- ✓ Applicant name
- ✓ Business Email
- √ Company Name
- ✓ Business Contact Number
- ✓ Auditing Organisation Name:
- √ Assessor Name
- ✓ Address of on-site assessment
 - Preferred time for assessment
 - I.E. Consider 9am if full day is required





bizSAFE Enterprise Exemplary Award – Application process

- 5. Things to note when booking WSH Council officer's availability:
 - On-site assessment starts from 15th May 2023
 - Confirm the availability of your assessor before you book a date in the booking system.
 - Do not 'chope' multiple dates in advance for the assessment, only book the confirmed date for the assessment
 - Earliest booking date is 3 days later from date of booking (e.g. Applicant access the booking system on 15 May 2023, date for booking is only available on 18 May 2023 onwards.)
 - Submission of online application form to WSH Council must be done before the on-site assessment date.
 - WSH Council will not accept booking of on-site assessment after 5 July 2023 (last day)
 - WSH Council will send a confirmation email once booking is successful.

For Assessors:



You play a very important role!

Please <u>double check</u> with your client to make sure they have received the confirmation email from WSH Council before carrying out the on-site assessment on the date, time and venue indicated in the email.

Remember to complete the declaration form for assessor in the RM Implementation checklist after the on-site assessment.

How to apply

- 3. Proceed with the on-site assessment on the date, time and location submitted in the booking system.
 - On-site assessments by auditors must be conducted in the presence of a WSH Council
 officer, failing which your application will be disqualified.
- 4. Upon completing the on-site assessment, upload the completed RM Implementation Checklist (with auditors' scoring) and supporting documents / evidences into the OneDrive folder before the application deadline (7 July 2023).

bizSAFE Champion Award



bizSAFE Champion Award

Recognise individuals who have been key players in improving safety and health performances in their workplaces.

These are employees who have been appointed by their companies to lead and drive the successful implementation of WSH programmes to attain bizSAFE.





bizSAFE Champion Award – Application criteria

The nominated champion should:

- represent a company that has achieved bizSAFE Star
- be a full-time employee of the company (non-WSH Officers will have an advantage);
- have attended the bizSAFE Level 2 course (Develop a Risk Management Implementation Plan) or its equivalent;



bizSAFE Champion Award – Application criteria

The nominated champion should:

- not be part of the management team (i.e. not in the top two tiers of your organisational chart);
- be active in driving WSH programmes and initiatives for at least 2 years in the company
- Bonus points will be awarded to the champion, if the company he/she is representing wins the bizSAFE Exemplary or Partner award





Recognise bizSAFE Enterprises that have:

 Committed to enhance workplace safety and health through the adoption of tech-enabled solutions.





WSH Tech Awards- Application Criteria

You are welcome to apply if you have:

- Achieved at least <u>bizSAFE Level 3</u> and above
- have adopted effective technology to mitigate WSH risks

*Note: Applicants should only submit <u>ONE</u> application to feature the adoption of technologies at the workplace



WSH Tech Awards— Application Criteria

- No blacklist record, pending investigation, conviction or prosecution in court by the Ministry of Manpower (MOM)
- Do not have any of the following during the qualifying period:
 - Fatality case
 - Major injury case
 - Dangerous occurrence case
 - Stop work order
 - Business Under Surveillance (BUS)
- Companies applying for the awards <u>may be</u> disqualified if they have cupational diseases within the qualifying period

WSH Tech Award – Assessment

Part A: Adoption of Technology to improve WSH (40%)

Problem Statement:

Describe your WSH Issue

Technologies adopted

- Describe how the technology or technologies can effectively address the WSH Issue
- 2. Scale of Implementation
- 3. Capital and operating cost of the technology/ technologies on a per worker basis.



WSH Tech Award – Assessment

Part B: Impact of WSH Tech to be assessed before and after implementation (60%)

- Injury rate
- WSH incident / Near-miss / Risky situation pertaining to the WSH Issue
- Man-hours for the task
- Any other metrics to show the benefits for the application of the tech-solution

Note: Supporting documents are to be provided for the topics assessed in Part A and Part B



WSH Tech Award – Interview session

 Shortlisted companies will be interviewed based on the submission of the write-up and the supporting documents provided.







1. Are there any costs involved for applying the bizSAFE Awards?

There will be no cost for applying of bizSAFE Awards. However, If you are applying for bizSAFE Enterprise Exemplary Award, the applying company may need to pay a service fee to the Auditing Organization (AO) for the on-site assessment.

2. Can I reschedule the on-site assessment for bizSAFE Enterprise Exemplary Award if there are any changes in work schedule?

Yes, click on the 'reschedule button' in the confirmation email you received and select a new date for the on-site assessment.



3. Why can't I access the OneDrive folder created for me to upload my supporting documents?

Check with your company IT department to make sure your company policy allows you to access online cloud storage or email to bizsafeawards@wshc.sg and provide an alternative email address that can access OneDrive.

Due to security reasons, WSH Council will only allow submission through OneDrive.



4. I received an error message indicating "file path name exceeds the limit" when accessing the file in the OneDrive to make adjustment on the uploaded documents.

The file directory in OneDrive folder is limited to 255 characters. As the primary folder created for your company will take up appx 60 - 75 characters, applicants are advised to ensure that all file names have less than 180 characters each and do not create multiple sub-folders.

Example of lengthy file name:

C:\Users\wshrtn\OneDrive - TAL\BizSAFE Partner Awards\ Applications\XYZ CONSTRUCTION\WSH Policy and Governance\1.1c Explaining WSH requirement of Job Scope and appointment letter of machine operator

Example of file name within 180 characters:

C:\Users\wshrtn\OneDrive - TAL\BizSAFE Partner Awards\ Applications\XYZ CONSTRUCTION\ RM implementation chklist 1.1c
