### **About WSH Performance Awards**

This award recognises companies that have implemented exemplary safety and health management systems and went to extraordinary lengths to safeguard their employees and contractors across all their worksites.

#### Award presented as follows:

Excellence	<ul> <li>No workplace incident occurred within the qualifying period</li> <li>To be shortlisted for evaluation, applicant needs to be a recipient of the Gold Award for three or more years consecutively</li> </ul>
Gold	<ul> <li>No workplace incident occurred within the qualifying period</li> <li>To be shortlisted for evaluation, applicant needs to be a recipient of the Silver Award for three or more years consecutively</li> </ul>
Silver	Good safety and health performance and systems


#### From 1 Jan 2022 to 31 Dec 2022, company must meet the following conditions:

  - Minimum 1.5 million manhours achieved in 2022
  - Company injury rate must be lower than the industry injury rate (WSH National Statistics 2022) by 50%

# Safety and Health Award Recognition for Projects (SHARP)



### **About SHARP**

This award recognises <u>large-scale projects or worksites</u> that have exemplary safety and health performance, and good workplace safety and health management systems.



- Provide EBA Part 3 Section B writeup, Section C and D table, and all supporting documents for auditors' verification
- Construction companies can use their ConSASS 2020 results (from Oct 2022 onwards), with a total element score of at least 70% for Band III

This award recognizes developers who play an active role in ensuring good workplace safety and health practices among their contractors.

Note: To win the award, applicants that have nominated the Developer must win:

- Three WSHPA or SHARP in 2023; or
- Two WSHPA or SHARP in 2022 and 2023

Applicant must be nominated by the WSHPA or SHARP applicants



## WSH Developer Awards Application Criteria



#### From 1 Jan 2022 to 31 Dec 2022, developer must meet the following:

- 1. No workplace accident across all worksites that led to fatality and major injury
- No breach\* in workplace safety and health, and labour matters of main contractors in all project or worksites

\*Includes Stop Work Order; Business Under Surveillance Programme; more than two compound fines (or fines exceeding \$2,000) including health-related offences from MOM Occupational Safety and Health Division; demerit points; WSH-related investigations, conviction or prosecution (including pending cases) with regard to workplace and labour matters under the Workplace Safety and Health Act and Employment Act.

## WSH Innovation Awards Application Criteria



#### Companies with an innovative solution that meets the following:

- 2. Led by teams comprising employees
- Focused on:
  - Minimising safety hazards such as work at height. The solution may be in the form of engineering measures, practices or safety systems that eliminate, control or significantly reduce a hazard's risks;
     OR
  - Implementing upstream risk control to eliminate or minimise risks from workplace health hazards such as chemicals, noise and ergonomics
- Resulted in significant improvement in WSH
- 4. Implemented for at least six months with no reportable accident or incident in the workplace
- 5. Has in place effective risk control measures which do not create or lead to new risk(s)
- 6. Does not infringe any copyright or patent law

### **About WSH Awards for Supervisors**

This award recognises supervisors who take care of their workers by improving the safety and health performance in their workplaces.





#### The nominated supervisor must meet the following:

- 1. Either a Singaporean/ PR/ S Pass/ Work Permit holder
- 2. Worked at least two years in the company as a supervisor
- 3. Performed junior supervisory role instead of managerial role
- 4. Oversaw a team of at least five workers





#### From 1 Jan 2022 to 31 Dec 2022, the following must be met:

- 1. No accident that caused death or permanent disablement to workers under supervisor's care
- 2. No breach\* in workplace safety and health\*\* matters in the company, which is under his/her charge

#### \*Includes:

- Stop Work Order
- Business Under Surveillance Programme
- More than two compound fines (or fines exceeding \$2,000) including health-related offences from MOM Occupational Safety and Health Division
- Demerit points
- WSH-related investigations, conviction or prosecution (including pending cases) with regard to workplace and labour matters under the Workplace Safety and Health Act and Employment Act

<sup>\*\*</sup>Excludes COVID-19 related matters





From 1 Jan 2022 to 31 Dec 2022, supervisors whom employers are nominating must also:

- 3. Attended at least one WSH course in obtaining or refreshing related knowledge on emerging technical skills and generic competencies

- Before the announcement of results, applicants may be disqualified if there is any:

  - Dangerous Occurrence (DO)
  - Adverse reporting
  - Inaccurate, false or misleading statistics, records, data or supporting documents
  - Withdrawal or amendment to their WSH Incident Report and/ or details to an ongoing work injury claim during application period
