### **About WSH Performance Awards**

This award recognises companies that have implemented exemplary safety and health management systems and went to extraordinary lengths to safeguard their employees and contractors across all their worksites.


The WSHPA is presented as follows:

Excellence	To be shortlisted for evaluation, applicant needs to be a recipient of the Gold Award for three or more years consecutively
Gold	To be shortlisted for evaluation, applicant needs to be a recipient of the Silver Award for three or more years consecutively
Silver	Good safety and health performance and systems



### WSH Performance Awards Entry Criteria

Qualifying period: 1 Jan 2023 to 31 Dec 2023



\*Minor injuries include any instance of medical leave or light duties.



### WSH Performance Awards Definition of injury

**Major injuries** are non-fatal but severe injuries, defined by nature of injury, part of the body injured, incident type and duration of medical leave. Examples include:

- Amputation
- Blindness
- Deafness
- Paralysis
- Crushing, fractures and dislocations
  - head, back, chest and abdomen, neck, hip and pelvis
- Exposure to electric current
- Asphyxia or drowning
- Burns with more than 20 days medical leave
- Concussion with more than 20 days medical leave
- Mosquito borne diseases with more than 20 days of medical leave
- Virus outbreak with more than 20 days of medical leave

**Minor injuries** refer to non-severe injuries with any instance of medical leave or light duties.

# Safety and Health Award Recognition for Projects (SHARP)






This award recognises <u>large-scale projects or</u> <u>worksites</u> that have exemplary safety and health performance, and good workplace safety and health management systems.



### SHARP Entry Criteria

Qualifying period: 1 Jan 2023 to 31 Dec 2023



\*Minor injuries include any instance of medical leave or light duties.



### **SHARP** Definition of injury

**Major injuries** are non-fatal but severe injuries, defined by nature of injury, part of the body injured, incident type and duration of medical leave. Examples include:

- Amputation
- Blindness
- Deafness
- Paralysis
- Crushing, fractures and dislocations
  - head, back, chest and abdomen, neck, hip and pelvis
- Exposure to electric current
- Asphyxia or drowning
- Burns with more than 20 days medical leave
- Concussion with more than 20 days medical leave
- Mosquito borne diseases with more than 20 days of medical leave
- Virus outbreak with more than 20 days of medical leave

**Minor injuries** refer to non-severe injuries with any instance of medical leave or light duties.

### WSH Performance Awards and SHARP Auditing Services Requirements

For applicants applying with the ConSASS 2020/ WSHMS 2020 checklist

Pre-Audit Self-Check

• Conduct a self-assessment before engaging auditing services to ensure all criteria are met.

#### **Exemption for Construction Companies**

 Construction companies or worksites can forgo engaging an approved Auditing Organisation (AO) if ConSASS results (from October 2023 onwards) meet the requirement of a total element score of at least 70% for Band III.



# WSH Performance Awards and SHARP Auditing Services Requirements

#### SAC Accredited WSH Auditing Organisations (AO) Engagement

• Engage auditing services through a SAC accredited WSH AO within the industry scope, as listed on MOM's website.

#### **Limitations on AO Appointment**

• Change AO after two consecutive years; appoint a different AO for the third year.

#### **Auditor Allocation**

 Limit each auditor to conducting audits for up to three Award applications from the same UEN; engage multiple auditors from the same/different AO(s) for multiple applications.

# WSH Innovation Awards Entry Criteria

Qualifying period: 1 Jan 2023 to 31 Dec 2023

#### The innovative solution should:

- Not breach WSH and labour matters due to project implementation
- Engage teams comprising employees and [new] contractors leading the project
- Focus on minimising safety hazards or implementing upstream risk control
- Have resulted in significant improvement in WSH
- Be implemented for at least six months with no reportable accident or incident in the workplace due to project implementation
- Be effective risk control measures which do not create or lead to new risk(s)
- Not have infringement towards any copyright or patent law

A maximum of three winning teams from each association will be nominated for further evaluation to receive the WSH Award at the national level.

# **About WSH Awards for Supervisors**

This award recognises supervisors who take care of their workers by improving the safety and health performance in their workplaces.



### WSH Awards for Supervisors Entry Criteria

Qualifying period: 1 Jan 2023 to 31 Dec 2023

#### Supervisors whom employers are nominating must have:

- 1. No accident that has caused death or permanent disablement to workers under his/ her care
- 2. No breach in WSH matters in the company under his/ her charge
- 3. Illustrated the commitments to show that he/ she:
  - Takes care of workers
  - Contributes to improving the company's WSH performance
  - Has been active in the support for workers' welfare
- 4. Attended at least one WSH course at the supervisor level

#### Note: All supporting documents must be uploaded on OneDrive

### WSH Awards for Supervisors Entry Criteria

The nominated supervisor must meet the following:

- 1. Either a Singaporean/ PR/ S Pass/ Work Permit holder
- 2. Worked at least two years in the company as a supervisor
- 3. Performed junior supervisory role instead of managerial role
- 4. Oversaw a team of at least five workers
- 5. [new] Not past winner for WSH Awards for Supervisors for last five years



All other applications will be evaluated by WSH Council

\*Applicants from the marine industries are to submit their application directly to ASMI.

Shortlisted applicants may be required to attend an interview.

A maximum of three winning supervisors from each association will be nominated for further evaluation to receive the WSH Award at the national level.

# **About WSH Officer Awards**

This award recognises exemplary performance and valuable contributions by registered WSH Officers for cultivating safe and healthy workplaces in Singapore.



#### WSH Officer Awards Entry Criteria

The registered and practising WSH Officer must meet the following:

- 1. Worked in the company for at least two years
- 2. Registered as a WSH Officer for at least five years
- 3. Attended at least one WSH course in obtaining or refreshing related knowledge on emerging technical skills and generic competencies
- 4. Application must be supported by their company
- 5. <sup>[new]</sup> Not past winner for WSH Officer Award in last five years



#### WSH Officer Awards Entry Criteria

Qualifying period: 1 Jan 2023 to 31 Dec 2023

The registered and practising WSH Officer must meet the following conditions:

- 1. No accident that caused death or permanent disablement in the company
- 2. No breach in WSH matters in the company
- 3. Implemented initiatives and/ or programmes within company that improved company's WSH performance
- 4. Contributed to the industry with proposals and implementations in cultivating safe and healthy workplaces





# bizSAFE Enterprise Exemplary Awards – Application Criteria

You are welcome to apply if you:

- Are a Small and Medium Enterprise (SME)\* (excluding WSH Service Providers)
- Have attained bizSAFE Star
- Have implemented a Risk Management Plan that is holistic and pragmatic, where upstream risk controls and personal health risks are considered
- Are not a WSH Performance Awards applicant in WSH Awards 2024



At least 30% shareholding that is local AND

One of the following:

i. A group employment size of not more than 200 employees (including part-timers) OR;

ii. A group annual sales turnover of not more than \$100 million.

# bizSAFE Enterprise Exemplary Awards – Application Process

- 1. Do a self-score using the RM Implementation Checklist (download from WSH Awards webpage). We recommend a score exceeding 80% before you engage an auditor to assess your application.

- 3. Engage an auditor\* to conduct a 3<sup>rd</sup> party assessment of your application Please refer to the application form for the list of approved auditing organisations.



4. After you submit the online form, you will receive a link to the booking system. WSH Council will verify the process by observing the assessment conducted by the auditor.


- 5. Things to note when booking WSH Council officer's availability:
  - Booking of on-site assessment will be open from 24<sup>th</sup> Jan 15<sup>th</sup> April 2024. Requests for booking of on-site assessments will not be accepted after 12<sup>th</sup> April 2024.
  - Confirm the availability of your assessor before you book a date in the booking system.
  - Do not 'chope' multiple dates in advance for the assessment, only book the confirmed date for the assessment
  - Earliest on-site assessment date will be 3 days from the date of booking (e.g. Applicant access the booking system on 1 Feb 2024, date for booking is only available on 4 Feb 2024 onwards.)
  - On-site assessment is to be completed by 15<sup>th</sup> April 2024. (3 days before Awards application closed)



- 3. Proceed with the on-site assessment on the date, time and location submitted in the booking system.
  - On-site assessments by auditors must be conducted in the presence of a WSH Council officer during the stipulated period, failing which your application will be disqualified.

Part A : Adoption of Technology to improve WSH (40%)

Problem Statement:

- Provide the product or the solutions of the WSH Technology implemented
- Describe the WSH Issue

Technologies adopted:

- 1. Describe how the technology or technologies can effectively address the WSH Issue
- 2. Provide the Scale of Implementation
- 3. Capital and operating cost of the technology/ technologies on a per worker basis.



#### WSH Tech Awards – Assessment Criteria

Part B: Assessment of WSH Tech impact pre-post implementation (60%)

- Injury rate
- WSH incident
- Near-miss
- Man-hours for the task (pertaining to the WSH Technology implemented)
- Any other metrics to show the benefits for the application of the tech-solution

Note: Supporting documents are to be provided for the topics assessed in Part A and Part B



#### WSH Tech Awards – Interview session



#### **Checks on Incident Report**

• All incident reports reported with the Ministry of Manpower (MOM) will be checked; any discrepancies may lead to immediate disqualification.

#### **Additional Evaluation**

• A presentation, interview session, and/or visit to the applicant's workplace may be arranged.



## **Disqualification before Announcement of Results**

#### Workplace Accident or Infringement

• Disqualification if a workplace accident with fatal, major injury, dangerous occurrence, or MOM legislation infringement occurs.

#### Inaccurate Information or Adverse Reporting

• Disqualification for inaccurate, false, or misleading supporting documents, records, or data, and adverse media reporting on workplace safety and health performance.

#### WSH Incident Report and Work Injury Claim

• Disqualification if an applicant withdraws or amends WSH Incident Report and/or an ongoing work injury claim during the application period; an investigation will precede further consideration.

- WSH-related investigations, conviction or prosecution (including pending cases) under legislation within MOM's purview
