



Status Update for OA Applications



Scope of OA Application – Pre-requisites and supporting documents (1/2)

- Defined roles and responsibilities of the CEO, System Admin Officer, Finance Officer, Management Rep as well as their information;
- Procedural write-up and workflow for refund policies and the administration system for submission of assessment results into the SkillsConnect (SCN) portal;
- One-year track record in the training and education field;



Scope of OA Application – Pre-requisites and supporting documents (2/2)

- Sufficient line-up of the Adult Educators (AEs) and ensuring that they have met the requirements of at least 80% of trainers and / or assessors with either ACTA or ACLP qualification or equivalent;
- All Curriculum developers are required to hold a DACE qualification; and
- Most recent 3-year financial statement and/or other records to justify business continuity.

General Issues

 Some of the LSPs select the wrong framework during their OA application. The correct framework to be selected is Generic Manufacturing Skills (GMS). Incorrect selection of the framework may lead to a delay in processing the application.



Status Update for CA Applications



Scope of CA Application – Supporting Documents to be uploaded

- AE Qualifications Requirements: Training and Technical Qualifications Certificates AND current CVs of Developer, Trainer and Assessor
- LSP certification + ISO29990/29993 certification
- Courseware (Lesson Plan, Learners' Guide, Facilitator's Guide, Powerpoint Presentation etc.)

ATO must review and develop revised courseware to align with CS/CTAG within 12 months of course approval. Revised courseware should aim to improve training and assessment efficiency and reduce language barriers for the target workforce.

 Please ensure that a Curriculum Developer is selected for each course application



General Issues

 Select the Cost Components that are relevant to your Training Organisation



 Select "Course fee per trainee (excluding GST)" if the proposed fee is for the entire course (not just Assessment)



For Compliance

- Training Providers should not submit applications for newlyapproved LSP courses as part of the transition
- Newly-appointed Training Providers should not submit applications for these courses until after 1 July 2020
